The sinful history record interruption of civilization and artistic communication in Egypt for centuries for the prosecution of other civilizations, after the end of the ancient Egyptian times, eras Islamic Revival great in terms of construction and Islamic Architecture Arts, only the popular technical industries have not left the Arts has taken to taper off at the end of Mamluk and Alasralosmany .

When the French campaign came to Egypt 1798- 1801 m focused on collecting and recording everything in Egypt, such as objects and popular life and celebrations, as well as personal pictures for months chieftains of that period, which has had a significant impact in directing the attention of the Egyptian elite to the field of fine arts.

With the beginning of the twentieth century, the first writings of the Egyptian intelligentsia that talked about the importance of the fine arts have emerged, and its role in the uplift of the individual and society, and the need to define the Egyptians. He was at the forefront of these: Sheikh thinker «Mohammed Abdo», and «Mezni» which set in his message harvest wildfire photography, and how it involves a deep understanding of the meaning of art.

And then we had the social impact of art Altsoaraly Egyptian society in the period the study between 1980 - 2012 as one of the most important periods in the history of Egypt's most controversial, and the owner of this period of political, economic, intellectual and religious factors that have had a deep impact on the direction of fine art in that period.

Chapter II Doralphen in the development of Egyptian society, and the research in this chapter shed light on the role of art in the development of Egyptian society and its treatment of social problems and national events that have passed on modern Egyptian society.

The second stage, when established the Fine Arts School in (1908) and appeared pioneers in graduation where, carrying the responsibility of the search for the Egyptian character in the art, after it was restricted only when recording appearance outside the Egyptian life limits, where Asttaau dialogue with the first pioneers of the renaissance intellectual Egypt in to be Menbin Bnteghm skip the traditional academic learned at the hands of foreigners, Nhwaltobeir for their betterment Egypt and nationalism, despite their attitudes and contrast their visions and longer this stage is the real beginning of the modern Egyptian art.

The third phase with the beginning of Althelignat came, a gelling and maturity period among the pioneers of photography Egyptians, and the beginning of the formation of the real Egyptian imaging features, where he participated Egyptian artists in the teaching of art and began to Egyptian art to emerge and take shape and the appearance of Egyptian artists have their issues, their community and they express about him and nationalism their issues .

As for the second chapter has dealt with the social influences on the art of photography in the period between 1980- 2012, Art is the community perception of the two cultural tool, because art does not evolve their own inner logic without the intervention of any factors outside the area belong to him, but it is always linked to the social worker who is in reality, economic and political factor, cultural and historical matter at once.

The first is divided into several chapters and social conditions, as it is no doubt that this period witnessed great social changes in the vicinity of the Egyptian society had a larger impact on all aspects of life in Egypt, including Fine Art, where that period that resulted in a change in social conditions revolution at the end of that period, and it was the most important demands of social justice, which is taken in absence may gradually, as the public taste has changed a lot in that period, resulting in a change in attitudes of many of the arts to keep up with these social changes.

Also, this period witnessed a great revolution in Altknolgy and research, especially in the field of telecommunications area, which helped the cultural communication between the East and the West, and the convergence of many ideas between them, thus opening the door to globalization in many Eastern societies, including the Egyptian society.

And tries to look at this partial shed light on those social aspects and the reasons for the changes in society and the impact on the process of artistic creativity in that period.

Then touched second chapter to shed light on the political atmosphere of this period, as the political conditions have had a significant impact on all aspects of life, including fine art as these variables had a national traits, then the region has seen many changes, wars and crises, which has had an impact scouring the Egyptian society, as it was to put a big political impact on the general art as a kind of intellectual domination appeared on the beliefs and affiliations of these peoples and historical inheritance Vtathert these peoples and colors taken from the paths of culture and knowledge .

Then, the search light on the religious orientations, as is the Egyptian society of religious communities, which constitute a component of religious values, mainly from the Egyptian society components, and is no doubt that in that period with the presence of many of the social crisis was a tendency to religion, especially the religion of the Islamic religion, which constitute the majority of Egyptian society solution to address these crises, which led to the growth of mainstream religious dramatically in all directions, whether moderation moderate or conservative Kalltiarat Salafist and other than the effect on public taste and accept the arts in general, and accept threads work presented in this period.

He then discussed the research of intellectual attributes, where it is certain that this period witnessed a radical change in the thinking of the Egyptian society and orientations, with a difference in many of the social values of the Egyptian people was caused by all of the above factors and other economic and social conditions.

Also deteriorated the value of education and culture to a large extent no longer educated intellectuals and social Izhawn extent that Isthakoh in the framework of a consumer society resides Alamormen purely physical perspective.

As characterized by technical features prevailing in that period to erode social orientation, due to increased individualism and experiences formalism, and the factors that may also have helped in myopia socially oriented in that period in the field of Fine Arts is that it has been the consolidation of the idea of Globalization, be sure to state a significant

impact in the artistic decline within the community, lack interest in the deployment of cash books Oalphenah remains a factor can not be overlooked beside many other factors contributed to the estrangement between art and the public, including the small number of customized to display works of art halls, and lack of interest in the media generally art through the deployment of paintings in various journals or publish simplified objective criticism, illustrates the trends in modern art to the masses.

As for Part III Find in this section deals with some Egyptian artists who are in that era with different orientations and affiliation intellectual and in terms of the nature of the generation belonging to him, and review their work and their techniques used, and how they are affected concepts of modernity and Western arts and arts stemming from the Egyptian environment.

And deals with the explanation and analysis of the extent of social interaction for artists of this period and influenced by social, political and economic factors in their business.

When talking about the art of Egyptian photography in the period means the search, we find it difficult to divide the artists of that period and that Ndrjhm under in similar methods in performance as was the case in ancient art, which emerged in the late nineteenth century and early twentieth century at the global level schools, where each artist has become a self-experience and methods in a special performance, which may be similar in thought and content humanitarian or national.

As for the younger generation, which is the experience is a direct result of the social conditions of that period shall search lists some of the experiments, which have met with success in that period, and then review the most important local technical forums, which have significantly affected the technical trend in Egypt, especially the Youth Salon and the impact of Participants Balarhasat the Western expatriate.
